| <p><b>ATTENDED FUNERAL (funeral director's charges only)</b> <span style="float: right;"><b>£1,850.00</b></span></p> <p>This is a funeral where family and friends have a ceremony, event or service for the deceased person at the same time as they attend their burial or cremation.</p> <p>Taking care of all necessary legal and administrative arrangements <span style="float: right;">£ 725.00</span></p> <p>Collecting and transporting the deceased person from the place of death (normally within 15 miles of the funeral director's premises) into the funeral director's care <span style="float: right;">£ 255.00</span></p> <p>Care of the deceased person before the funeral in appropriate facilities. <span style="float: right;">£ 170.00</span></p> <p>The deceased person will be kept at the funeral director's branch premises</p> <p>Providing a suitable coffin – this will be made from oak/elm wood-effect chipboard <span style="float: right;">£ 295.00</span></p> <p>Viewing of the deceased person for family and friends <span style="float: right;">£ 60.00</span></p> <p>by appointment with the funeral director (where viewing is requested by the customer)</p> <p>At a date and time you agree with the funeral director, taking the deceased person <span style="float: right;">£ 345.00</span></p> <p>direct to the agreed cemetery or crematorium (normally within 20 miles of the funeral director's premises) in a hearse or other appropriate vehicle</p> |
| <p><b>UNATTENDED FUNERAL</b></p> <p>This is a funeral where family and friends may choose to have a ceremony, event or service for the deceased person, but they do not attend the burial or cremation itself.</p> <p><b>Burial (funeral director's charges only)<sup>1</sup></b> <span style="float: right;"><b>£ 995.00</b></span></p> <p><b>Cremation (funeral director's charges plus the cremation fee)<sup>2</sup></b> <span style="float: right;"><b>£1,131.00</b></span></p>   |
| <p><b>FEES YOU MUST PAY</b></p> <p>For an Attended or Unattended burial funeral, the <b>burial fee</b></p> <p>In this local area, the typical cost of the burial fee for local residents is: <span style="float: right;"><b>£715 - £1372.50</b></span></p> <p>For a new grave, you will also need to pay for the plot; for an existing grave with a memorial in place, you may need to pay a removal/replacement fee. In addition, the cemetery may charge a number of other fees.</p> <p>For an Attended cremation funeral, the <b>cremation fee<sup>2</sup></b></p> <p>In this local area, the typical cost of a cremation for local residents is: <span style="float: right;"><b>£946 - £1150</b></span></p>  |

<sup>1</sup> This fee (which is sometimes called the interment fee) is the charge made for digging and closing a new grave, or for reopening and closing an existing grave.

<sup>2</sup> In England, Wales and Northern Ireland, you will usually need to pay doctors' fees as well. This is the charge for two doctors to sign the Medical Certificates for Cremation.
